Mr. Cramer made a motion to have Brad Cerino return as Golf Maintenance Foreman at \$720/week to start on **3/13/2023; Al Hopkins at \$14.10/hour to start on 3/20/2023; Frank Streznetcky at \$13.50/hour to start on 3/27/2023 and to authorize Golf Course Superintendent and Golf Pro to bring back employees as needed**.
